Letter from the Director

e have had an extremely busy, highly productive year. Altogether, we hosted some twenty-five exhibitions and rotations from the collection, attracting an audience of nearly 200,000 visitors, not to mention the nearly two million others who visited the Morgan online.

The exhibitions we presented vividly reflected the scope, depth, and quality of our holdings. They ranged from *Illuminating Faith: The Eucharist in Medieval Life and Art to Edgar Allan Poe: Terror of the Soul, The Little Prince: A New York Story,* and *A Collective Invention: Photographs at Play.* They also included *Leonardo da Vinci: Treasures from the Biblioteca Reale, Turin* and *Tiepolo, Guardi, and Their World* as well as the first-ever museum exhibition of drawings by Matthew Barney.

Each of these projects was, in turn, the springboard for numerous programs—for gallery talks, lectures, films, conversations, and family days. In addition, we hosted a superb series of concerts—among them, sold-out performances of the Boston Early Music Festival's production of *La Descente d'Orphée aux Enfers* and *La Couronne de Fleurs* and a performance by the Scharoun Ensemble of works inspired by music in our own collection.

Last fall we announced an expansion of our weekend programs, with generous sponsorship from Morgan Stanley. In particular, we introduced live music in Gilbert Court on Sunday afternoons. As a consequence of these changes, attendance on Sundays has increased almost thirty percent.

At the same time, we made numerous new acquisitions. We treated hundreds more works in the Thaw Conservation Center. We assisted thousands of scholars. And our corps of volunteers swelled to the largest number we have ever had, providing invaluable assistance to sixteen departments.

We made steady progress toward the digitization of our collection—of our papyri, of our etchings by Rembrandt, and of our holdings of old master drawings. We also geared up for a significant expansion of our school program, starting within the next several months, as part of a major project for which we've received a grant from the Brooke Astor Fund for New York City Education in the New York Community Trust.

My appointment as Director of the Cleveland Museum of Art came following the close of the fiscal year, yet it is only logical to acknowledge my departure from the Morgan. Leaving will not be easy. This is a unique institution, and I believe that we have accomplished a lot together.

Since 2008, we've mounted nearly a hundred exhibitions, both on our own and in collaboration with such institutions as the Churchill Archives Centre; the Staatliche Graphische Sammlung, Munich; and the Bibliothèque nationale de France. We completed the Morgan's first comprehensive strategic plan. We restored the interior of our historic 1906 McKim building. And we established two new curatorial departments: Photography and Modern and Contemporary Drawings.

We could not do what we do without your generosity. I thank each and every one of you, on behalf of the staff and the millions of people who benefit from the work of the Morgan. I thank you warmly for the immensely rewarding opportunity of serving as Director of this great institution. With your continued engagement and support, the Morgan's future will be bright indeed.

Letter from the President

he Morgan is reaching a record number of people through its robust public and scholarly offerings. Some of this activity occurs here in New York. A growing share takes place around the world, as the Morgan's extraordinary collections and programs are available in digital and electronic form. This access is made possible by our generous donors: individuals, foundations, corporations and the government. Our mission is also sustained by revenue from the institution's permanent endowment, whose market value was \$191 million at the close of the fiscal year. Endowment funds are the critical foundation of a strong and sustainable organization.

For this reason, the Campaign for the Morgan is under way to add endowment capital, especially for unrestricted use. Still in the quiet phase, the campaign reached over \$47 million by the end of this fiscal year through gifts, grants and pledges. The Sherman Fairchild Foundation made a munificent grant of \$10 million toward unrestricted endowment. A very generous gift intended to endow unrestricted operations, technology and education, as well as to support current technology needs, was made by an anonymous donor.

New pledges and gifts to the Fund for the Morgan for unrestricted endowment were received from Rodney B. Berens, George L. K. Frelinghuysen, The Frelinghuysen Foundation, Charles F. Morgan and Peter Pennoyer. Major support from the Honorable Anne Cox Chambers established the Katharine Rayner Endowment Fund for unrestricted use. James R. Houghton created the Jamie and Maisie Houghton Endowment Fund to support exhibitions. James A. Runde made a gift to support exhibitions. T. Kimball Brooker augmented the T. Kimball Brooker Sixteenth Century Fund. Susanna Borghese made a gift to the Campaign. The Hearst Foundations made an award to the William Randolph Hearst Fund for Scholarly Research and Exhibitions, bringing the fund principal to \$1 million. Planned bequests from S. Parker Gilbert and Clement C. Moore were confirmed. In addition, the William C. Bullitt Foundation approved a planned gift on behalf of Robert M. Pennoyer. Pledge payments of more than \$100,000 were received from the Acquavella Family Foundation; the Charina Endowment Fund, established by Richard L. Menschel; the Andrew W. Mellon Foundation; Cynthia Hazen Polsky; and Beatrice Stern.

Individuals, foundations and corporations made substantial gifts, grants and pledges designated for acquisitions, specific projects and general operations. Gifts, grants and pledge payments in excess of \$100,000 for these purposes were received from the Estate of Brooke Astor; the Estate of Alex Gordon; the Estate of Marian O. Naumburg; the Brooke Astor Fund for New York City Education in the New York Community Trust; The Indian Point Foundation; the Leon Levy Foundation; Jonathan and Jeannette Rosen; and Morgan Stanley.

Membership increased steadily across all Friends' levels. The Young Fellows program was revitalized, with many new members joining during this fiscal year. Growth was also realized in the Patron Fellows level in the Association of Fellows.

I am pleased to note that we will launch our planned giving society in the fall. The 1924 Society—which takes its name from the year the Morgan opened to the public—will recognize those who inform us of their plans to make a gift as part of their estate.

Not long after the close of the fiscal year, our Director, Bill Griswold, informed the Board of Trustees that he had accepted the appointment of Director of the Cleveland Museum of Art. We are grateful for Bill's exceptional contributions to the Morgan and wish him much success. Peggy Fogelman, our Director of Collections, agreed to serve as Acting Director while a search for the next Director is in progress. I am confident that new leadership will invigorate an already vital, forward-looking institution.

MAY IO-SEPTEMBER 8, 2013

Subliming Vessel was the first museum exhibition devoted to Matthew Barney's works on paper. The exhibition included nearly one hundred drawings spanning the artist's career to date.

MAY 31-OCTOBER 6, 2013

This show explored the recent growth of the Morgan's collection of drawings. More than a hundred drawings were on view, including major gifts from such notable collectors as former Morgan Director Charles Ryskamp, Trustees Eugene V. Thaw and Brooke Astor, and long-standing supporter Joseph McCrindle. An important group of recent purchases, including those made on the Sunny Crawford von Bülow Fund, were also displayed.

Bookermania 45 Years of the Man Booker Prize

SEPTEMBER 13, 2013-JANUARY 5, 2014

This exhibition celebrated the Morgan's Man Booker Prize Collection—the largest American collection devoted to the prize, acquired in 2010. The exhibition traced the illustrious history of the prize through a chronological arrangement of every winner and select nominees from 1969 to 2012.

Tiepolo, Guardi, and Their World Eighteenth-Century Venetian Drawings

Drawn entirely from the Morgan's holdings, this exhibition featured a selection of more than one hundred works on paper and chronicled the vitality and originality of drawing during Venice's second Golden Age.

Edgar Allan Poe Terror of the Soul

OCTOBER 4, 2013–JANUARY 26, 2014

The exhibition featured nearly one hundred Poe items, drawn primarily from the Morgan's holdings and The Henry W. and Albert A. Berg Collection of English and American Literature at The New York Public Library, two of the most important collections of Poe material in the United States.

Leonardo da Vinci Treasures from the Biblioteca Reale, Turin

OCTOBER 25, 2013-FEBRUARY 2, 2014

For the first time in New York, the Morgan presented Leonardo da Vinci's extraordinary Codex on the Flight of Birds, and one of his most celebrated drawings, the *Head of a Young Woman*. They were shown together with a selection of further drawings by Leonardo and his followers.

This exhibition was organized by the Morgan Library & Museum and the Italian Ministry of Foreign Affairs, the Ministry of Italian Cultural Heritage and Activities, the Embassy of Italy in Washington D.C., and the Biblioteca Reale in Turin in collaboration with the Italian Cultural Institute of New York and la Fondazione, New York. Visions and Nightmares Four Centuries of Spanish Drawings

JANUARY 17-MAY II, 2014

This exhibition marked the first presentation of Spanish drawings at the Morgan. Spanning the sixteenth through the nineteenth centuries, the selection of more than twenty sheets featured well-known artists such as José de Ribera, Bartolomé Esteban Murillo, and Francisco Goya.

The Little Prince A New York Story

JANUARY 24-APRIL 27, 2014

Focusing on *The Little Prince*'s American origins, this exhibition featured twenty-five of the manuscript pages and all forty-three of the earliest versions of drawings for the book. Also on view were rare printed editions from the Morgan's collection as well as personal letters, photographs, and artifacts on loan from the Saint-Exupéry estate, private collections, and museums and libraries in France and the U.S.

A Collective Invention Photographs at Play

The site-specific work was composed of thousands of sheets of handmade paper connected together with bookbinding yarn and suspended from the ceiling of the Morgan's Gilbert Court.

ROTATIONS AT FOUR-MONTH INTERVALS

Highlights from these installations included a mid-fifteenth-century English cooking scroll containing nearly two hundred recipes in Middle English; autograph music manuscripts by Wagner, Verdi, and Britten; the first book printed in the English language; a letter from Jane Austen; and an Albert Einstein manuscript.

Reflections on a Nation American Writings from the Gilder Lehrman Collection

SEPTEMBER IO, 2013-JANUARY I2, 2014

On display were exceptional documents from the Gilder Lehrman Institute of American History, one of the country's foremost archives of Americana. The selection represented the collection's strengths in documents from the Revolutionary, early national, antebellum, and Civil War periods.

Beethoven's Ninth A Masterpiece Reunited

OCTOBER 8-DECEMBER I, 2013

As part of the Bicentenary celebrations of the Royal Philharmonic Society, the Morgan displayed two historic copyist scores of Beethoven's Ninth Symphony, marking the first time they were brought together since their creation in 1824.

Charles Dickens's A Christmas Carol

DECEMBER 3, 2013-JANUARY 12, 2014

Every holiday season, the Morgan displays Charles Dickens's original manuscript of *A Christmas Carol* in Pierpont Morgan's historic Library.

Seals and Tablets and Migration-Era Art

The North Room in the McKim features over two hundred of the earliest works in the Morgan's collection, including objects from the Ancient Near East, Egypt, Greece, and Rome, as well as artifacts from the early medieval period.

School Programs

Exploring with the Morgan served 5,570 Pre-K–12 students, the majority from underserved communities in Manhattan, the Bronx, and Brooklyn. Seven enrichment programs, presented in the Horace W. Goldsmith Foundation Education Center and in classrooms around the city, offered students rare opportunities to incorporate primary resources from the Morgan's collection into their study of local and world history, art, social studies, and scientific disciplines.

The Morgan Book Project, developed by Morgan education staff in collaboration with the New York City Department of Education (NYCDoE) was offered for the fifth year. It served eighteen teachers and over 300 schoolchildren from nine NYC public schools. The Morgan also had the opportunity to share The Morgan Book Project with two educators from the UCLA Lab School. Twenty students from the UCLA Lab School were able to participate. The Morgan Book Project hosted a Summer Institute for Teachers and a technical support meeting prior to holding the Morgan Book Project Award Ceremony in April 2014. Held in the Morgan's Gilder Lehrman Hall, the ceremony culminated in a one-day installation for all winners and a special selection of students were able to place their books on display for a subsequent two-week exhibition.

The Morgan hosted seven professional development workshops for principals and teachers during the school year.

In addition to longstanding partnerships with organizations such as the NYC Department of Parks & Recreation, new out-of-school-time program relationships were developed to extend the efforts of the school program. Collaborations included GO Project, Art Without Walls, the Big Brothers and Big Sisters in partnership with the High School of Economics and Finance, Dominican Academy, PS 118Q, PS 163M, and the Harlem Children's Zone. These programs served 373 children from underserved city neighborhoods.

The programs of the Morgan Library & Museum are generously supported by grants from the Brooke Astor Fund for New York City Education in the New York Community Trust; Great Circle Foundation, Inc.; the May and Samuel Rudin Family Foundation, Inc.; MetLife Foundation; the Armand G. Erpf Fund; and by the following endowed funds: The Alice Tully Fund for Art and Music; the William Randolph Hearst Fund for Educational Programs; the Stavros Niarchos Foundation Fund for Education and Technology; and the Herbert and Ann Lucas Fund.

The programs of the Morgan Library & Museum are made possible in part with public funds from the New York City Department of Cultural Affairs in partnership with the City Council, and by the New York State Council on the Arts with the support of Governor Andrew Cuomo and the New York State Legislature.



Sherman Fairchild Reading Room

The Sherman Fairchild Reading Room had more than 1,300 reader visits in fiscal year 2014. Researchers consulted materials from every curatorial department. Thousands more made queries by email and telephone. Researchers included an international range of scholars, students, artists, writers, filmmakers, calligraphers, and musicians. Projects included the history of the Booker Prize, Episcopal missionaries and Sioux culture, marginalia in the works of Chaucer, embroidered bindings, Gustav Mahler's sketches for his Third Symphony, and the decoration of incunabula printed by the nuns at a Florentine convent. The Reading Room also hosted several class visits of both graduate and undergraduate students on topics ranging from history to architecture and visual art.

Drawing Institute

In its third year, the Drawing Institute, endowed by Life Trustee Eugene V. Thaw, continued to support research in the field of drawings through fellowships, lectures, symposia, study days, seminars, and colloquia. The third class of fellows comprised five scholars working on a wide range of topics: Portraits on Paper in Rome (ca. 1550-ca. 1650): History, Technique, Function, and Style; Posing in the Nude: Early Academic Drawing in Amsterdam, 1640s–60s; Between Practice and Precedent: French Drawing in Rome; Drawing and Francesco di Giorgio's Program for the Renaissance Architect; and Drawing, Writing, Speaking: Jean Dubuffet's "lerdlacanpane" (1948) and the Emergence of "Écrits Bruts." In 2013-14, the Drawing Institute organized lectures by Oliver Everett on the collection of the Royal Library at Windsor Castle and by

Carmen C. Bambach on Leonardo da Vinci, a symposium on oil sketches, a series of study days, as well as a Graduate Seminar on Rembrandt led by David Freedberg.

Research and Cataloging

2013 marked the second year of the Leon Levy Foundation's multi-year grant to the Morgan to enhance access to collections in the Department of Literary and Historical Manuscripts. Project staff created and upgraded more than 4,000 records for letters, journals, manuscripts, and other related items in the online collection catalog. Highlights included correspondence of Thomas Jefferson and Andrew Jackson, an ornate papal bull from 1537, and several collections related to British royalty.

Conservation

The Thaw Conservation Center continued to assist in a busy schedule of rotating exhibitions throughout the year. The different physical characteristics of the collection items on display demanded innovative solutions to installation challenges that not only protected the artworks while on view, but also presented them in visually attractive and fully informative ways. The exhibition schedule also resulted in a number of rewarding research pursuits, especially in the area of medieval manuscript production. The Center's commitment to education was underscored by a number of offerings pertaining to the material characteristics of paper, parchment and the marks made on them. A scholar's roundtable, Between the Covers: A Multidisciplinary Examination of a Sketchbook by Jean-Joseph Chamant, attracted over 45 attendees, including conservators, art historians, theater

historians, and curators, and also resulted in a short documentary film. One graduate intern, two post-graduate fellows, and an advanced conservation graduate student were hosted. An ongoing survey of medieval and Renaissance bindings continued, and an ambitious program to digitize the drawings collection was implemented.
